Company & I4WDTA Logo Workgear

Having been through 3-4 clothing vendors for Backroad 4WD Training, I was tired of buying sub-quality made clothing that the logo art would literally peel or fray off the garment would shrink or tear easily. I wanted made-in-the-USA clothing with a guarantee. I found 1620 work wear through a family member that had been using them for years in commercial use and had found them very durable. I contacted 1620 and found out they can do embroidery and silkscreen company logos. We worked with a rep that specialized in company logo workwear.

This past fall at TFC, several folks commented on the quality of our 1620 logo gear, and I wanted to share with the group that 1620 has the I4WDTA logo art

available for trainers to embroider on their gear. They can embroider or silk screen your company logo along with that service.

They are also offering a 20% discount on the purchase of gear using code I4DTWA. To have the I4WDTA logo embroidered on your garment is \$26.25 per garment. Your company logo cost will vary depending on how many colors you have in the logo for both embroidery and silkscreen.

We had our logo embroidered on the left chest area and the I4WDTA logo on the right sleeve/shoulder with a large logo silkscreened on the back (see attached photos). We have been using the gear for about nine months and are very satisfied with the durability and quality of the garment and the logo work. 1620 is not inexpensive, but after purchasing better than a dozen t-shirts and sweatshirts that are for shop use only now, it was worth it to us to buy quality this time around.

We purchased the Tech Hoddie with reinforced forearms and front pocket along with the shop pant, but 1620 makes all kinds of different workwear that they can logo for your business.

PRP Program: Product Testing & Evaluation

The PRP program, over the last few months, has had an uptick in interest. With five companies who have submitted products or shown interest in submitting products for evaluation.

Several small changes to the program that are taking a little time to complete are the use of NDAs from the companies who are submitting products. The NDAs are sent out to the trainers who have stated they want to participate in evaluating products. Once the NDAs are returned signed, a PRP evaluation specific to the product will be generated and sent to those instructors. Depending on the required detail of the evaluation, a set time to complete the evaluation will be provided. The PRP evaluations that go out are detailed in nature, requesting basic information on the instructor's equipment being used to evaluate atmospheric weather and terrain conditions for the purpose of collecting any failures or issues with the product. More detailed or specific information on the product is requested on each PRP evaluation so the instructor can capture information while using the product in training or the field. The PRP evaluations are set up to be able to print a few copies and capture data in the field easily while being used. This will allow the instructor to log information, problems, etc., when it happens and not have to do it after a trip or training and try to recall the information.

Once all evaluations are returned, I will work to generate a report, good or bad for the company and let them determine if they want it to be published on the Website for a product we recommend.

We currently have ongoing evaluations of the Hawse Pro fairleads, DMOS Shovels, and upcoming evaluations on some tire repair and tire sealant products as well as quick connect tire deflators. I'm awaiting some NDAs to be returned and drafting the evaluation forms for them. Please keep in mind the faster the responses and return of required documentation expedites the process and completing the evaluations and getting it to the company that provided the products.


